Don Liddycoat, Chair, called the meeting to order in open session at 2:08 pm.

Property Evaluation: Charlie Tveit, CEO reported that he is still negotiating the purchase price of the property and asked the Board to authorize him to purchase the lower priced building for a total of \$230k including needed repairs. Mr. Tveit noted that the door will have to be made ADA compliant, and once construction begins we could find additional issues, but feel the price is pretty accurate. Mr. Tveit reported that we hope to be using the building by the end of January. Ken Kestner made a motion to approve purchase of 220 North E Street, Lakeview OR and known improvements up to \$230k. John Shine seconded the motion. The motion was presented, and Don Liddycoat, Jerald Steward, John Shine, Ken Kestner voted to pass the motion unanimously.

Mr. Tveit reported that there is an opportunity to purchase a house near the hospital for a doctor to use, and at a previous meeting the Board had authorized him to purchase a home for up to \$250k. Mr. Tveit reported that this is a very nice place and would like to have authorization to purchase up to \$275k instead of \$250k for a single property. Ken Kestner made a motion to increase the authorized purchase amount from \$250k to \$275k. Jerald Steward seconded the motion. The motion was presented, and Don Liddycoat, Jerald Steward, John Shine, Ken Kestner voted to pass the motion unanimously.

Signatures on checks: Mr. Tveit reported that with Cheryl Cornwell, CFO leaving we need a second digital signature on the District checks and suggested that as Treasurer John Shine's signature be on file until a CFO is hired. Mr. Shine agreed.
